

ORDINANCE NO. 2010 - 104

AMENDING SECTIONS 205.01 AND 967.01 OF THE CODIFIED ORDINANCES OF THE CITY OF MASON REGARDING MEMBERSHIP RATES FOR THE MASON COMMUNITY CENTER

WHEREAS, Section 205.01 of the Mason Codified Ordinances establishes a fee schedule, including rates for the Mason Community Center; and

WHEREAS, Section 967.01 further addresses rates for the Mason Community Center; and

WHEREAS, it is the intent of Council to establish new rates for daily admissions and certain membership levels for the Mason Community Center.

NOW THEREFORE BE IT ORDAINED by the Council and City of Mason, Ohio, six members elected thereto concurring:

Section 1. That Section 205.01 of the Mason Codified Ordinances, as it relates to Mason Community Center fees, is hereby amended as set forth in Exhibit A, attached hereto and incorporated herein by reference.


Section 2. That Section 967.01 of the Mason Codified Ordinances is hereby amended as set forth in Exhibit B, attached hereto and incorporated herein by reference.

Section 3. That all prior ordinances establishing Community Center rates and fees are hereby repealed.

Section 4. That this Ordinance shall be in effect from and after the earliest period allowed by law.

Exhibit B

967.01 RATES FOR DAILY ADMISSIONS AND MEMBERSHIPS.

- (a) Rates established. There are hereby established the rates for daily admissions and memberships for use of the Mason Community Center. The fees shall be as established and set forth in the fee schedule in Part One – Title Eleven, Chapter 205 of these codified ordinances. The amount of the fees shall be as set by ordinance from time to time.
- (b) Rules and Regulations. The City Manager, or his designee, is hereby empowered to adopt and promulgate and to enforce rules and regulations relating to any matter or thing pertaining to the use, admission, and membership for the Mason Community Center, including provisions establishing and maintaining a membership loyalty program and the establishment of other periodic specials and discounts as warranted based on market conditions and competition.
- (c) Effective date. The fees shall be applicable toward any passes and memberships purchased on or after October 1, 2010, and on renewals of passes expiring after October 1, 2010.
- (d) Annual Adjustment. Beginning, January 1, 2012, the rates established by this section shall be adjusted, effective January 1 of each year, by a cost of living factor to be determined by Council on an annual basis. An adjusted annual rate schedule shall be posted at the Community Center and made available upon request.
