

ORDINANCE NO. 2010 - 82

AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH SUPREME AUDIO IN AN AMOUNT NOT TO EXCEED \$16,500.00 FOR THE MASON COMMUNITY CENTER RENOVATION PROJECT

WHEREAS, the City of Mason is currently renovating the Mason Community Center; and

WHEREAS, as part of the overall renovation project, audio towers are required in the aerobic rooms as part of the new renovations; and

WHEREAS, the City has contracted for audio towers equipment from Supreme Audio, in the amount of \$16,500.00, in accordance with the terms of the agreement, a copy of which is attached hereto and incorporated herein along with Exhibit "A" ; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Mason, Ohio, six members thereto concurring:

Section 1. That the proposal of Supreme Audio in the total amount of not to exceed \$16,500 for audio towers for the Community Center are hereby accepted.


Section 2. That the City Manager is hereby authorized and directed to enter into an agreement with Supreme Audio to provide audio towers for the Community Center according to the specifications set forth by the City.


