## **HIGHLIGHTS FOR 2021 TAX FILING YEAR**

**DEADLINE:** The tax filing deadline is **Monday, April 18, 2022.** There will be no late filing penalty charge added if the return is in our office by 4:30 p.m. on **Monday,** April 18th, in the City drop box at Mason Municipal Center by midnight, e-filed, sent using the Secure Email link, or postmarked on or before April 18, 2022.

**E-file**ONLINE TAX TOOL with E-FILING: Calculate your taxes online. Beginning February 9, 2022, an online tool to help you calculate your tax return will be available at <a href="www.imaginemason.org">www.imaginemason.org</a>. You will need the account number found near your name and address on the letter that you received in January and the last 4 digits of the primary account holder's social security number. Even if you used the tax tool last year, you will need to activate your online tool account (setting up a new password and PIN) the first time you log in after 2/9/22. You may also upload copies of your W-2(s), Federal Return and Schedules, etc. If you meet the criteria, you will be given the <a href="mailto:option">option</a> of e-filing your tax return (be sure to click the button to submit the e-filing); otherwise, please remember to print and mail the return with the appropriate attachments. <a href="Please Note: Partial year residents will not qualify to e-file">please Note: Partial year residents will not qualify to e-file</a>.

**ASSISTANCE:** The Tax Office may be reached with questions by phone at (513) 229-8535 during regular business hours (Monday through Friday 8:00 a.m. to 4:30 p.m.). **Please check the website (www.imaginemason.org) to see if in-person tax preparation or extended hours are available.** If you need help filling out your Mason Income Tax Return, you may still submit copies of the necessary supporting documents and information (see "Enclosures" section below) to the Tax Office and **we will prepare the return free of charge**. Documents may be submitted via the Secure Email link at <a href="www.imaginemason.org">www.imaginemason.org</a>, mailed, or sealed in an envelope and placed in the City's drop box located in the drive outside the Municipal Center's main entrance (6000 Mason-Montgomery Road, Mason, OH 45040).

Please ensure any documents submitted to the Tax Office are duplicate *copies*; originals will not be returned to you. If we receive the necessary document copies on or before 4/18/22, your Mason return will be considered filed on time, although it may take several weeks for the return to be prepared and a copy sent to you.

**EXTENSION:** If additional time is needed in order to complete an accurate return, a filing extension may be requested by submitting a copy of your federal extension or by filling out and submitting the Mason Extension Form ER between 1/15/22 and 4/18/22. *Please Note: An extension of time to file is not an extension of time to pay taxes due.* 

**ENCLOSURES:** When sending your return (Form IR or IR-EZ) to the tax office, please include your W-2(s), a copy of page 1 of your Federal Form 1040, Federal Schedule 1, and any other applicable schedules/forms (see below\*). The Mason Tax Ordinance requires the first page of the Federal 1040, if filed, and Federal Schedule 1 to ensure all taxable income is reported to the City and that any nontaxable income is not included on the City return. If applicable, additional federal schedules and other forms will be required to support items listed on the Mason return. \*These include Schedule C (Profit or Loss from Business); Schedule E (Supplemental Income and Loss), which includes income from rentals, partnerships, S corporations, estates and trusts; Schedule F (Profit or Loss from Farming); Form 4797 (Sales of Business Property); 1099-MISC (Miscellaneous Income); 1099-NEC (Nonemployee Compensation); and W-2G (Certain Gambling Winnings). Please remember to also include any (1) copies of returns filed with other cities (to receive credit for taxes paid to or to indicate refunds issued by other cities), (2) federal extension, and/or (3) part-year residency explanation.

**TAXABLE WAGES:** The income in Box 5 of the W-2 is generally the amount taxable to the City of Mason. If Box 5 is blank, please consult the Step-By-Step Instructions and General Information sheet or call our office at 513-229-8535 to determine the taxable amount.

**ROUNDING:** Please round the numbers on your tax return to whole dollar amounts. We do not collect, refund, or carry over amounts \$10 or less.

**USING NET OPERATING LOSS (NOL):** Beginning tax year 2017, the State of Ohio made changes to the amount of loss carry-forward that may be used on your return. Up to 100% of the allocated loss remaining from tax year 2016 may still be used. The deduction of losses from tax years 2017-2020 is limited to the **smaller** of the following amounts: **(A)** 50% of the unused 2017-2020 losses or **(B)** 50% of the net non-W-2 income left after any 2016 loss has been applied. **Note: Losses cannot be used to offset W-2 income.** 

**PENALTY and INTEREST:** Late filing penalty applies to returns submitted after the 4/18/22 due date (or after 10/15/22 if under extension). This penalty is \$25 per month or fraction thereof, not to exceed \$150.

<u>Late payment penalty and interest</u> applies to all tax remaining unpaid **after becoming due**. (90% of your actual 2021 tax liability is due by 1/15/22. Any remaining tax balance is due by 4/18/22 – even if a filing extension has been granted.) The late payment penalty rate is 15% of the amount not timely paid. The interest rate is adjusted annually based on the federal short-term rate plus 5% and is 0.42% per month for calendar year 2022.

**ESTIMATED PAYMENTS:** Please remember that 90% of your actual 2022 tax liability is due by **January 15, 2023**. You can make estimated payments via the Online Tax Tool. You may also mail or make a payment at the Mason Municipal Center. If needed, blank vouchers are available online at <a href="https://www.imaginemason.org">www.imaginemason.org</a>.
