One male stated that he knew nothing and the other stated that a man left some time before the outage but he did not know who he was.

I then spoke with the owner of the Pleasure Inn. He did not recall anyone leaving or arriving around the time of the outage but stated that he would ask around and get back with me if he found anything out. I gave him a business card.

On 02-14-12, I responded back to the Pleasure Inn. The owner was not there but the female bartender was there who was also present on the night of this incident. I asked her if there was any update and she did not know of anything.
