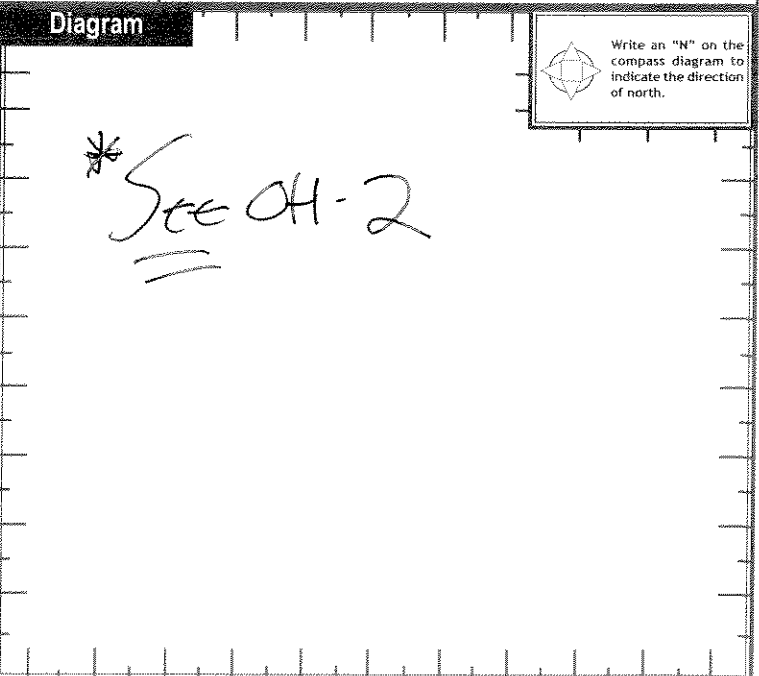

Narrative

Unit #1 was Southbound on Mason-Montgomery in the right lane of the 6800 block. Unit #2, also Southbound on Mason-Montgomery Rd., in the left lane of the 6800 block. Unit #1 attempted to change lanes into left hand lanes at high rate of speed for the area but was unable to pass without striking right front of Unit #2. This caused Unit #2 to spin out and Unit #1 to loose control, ultimately striking curb + tree in the median.

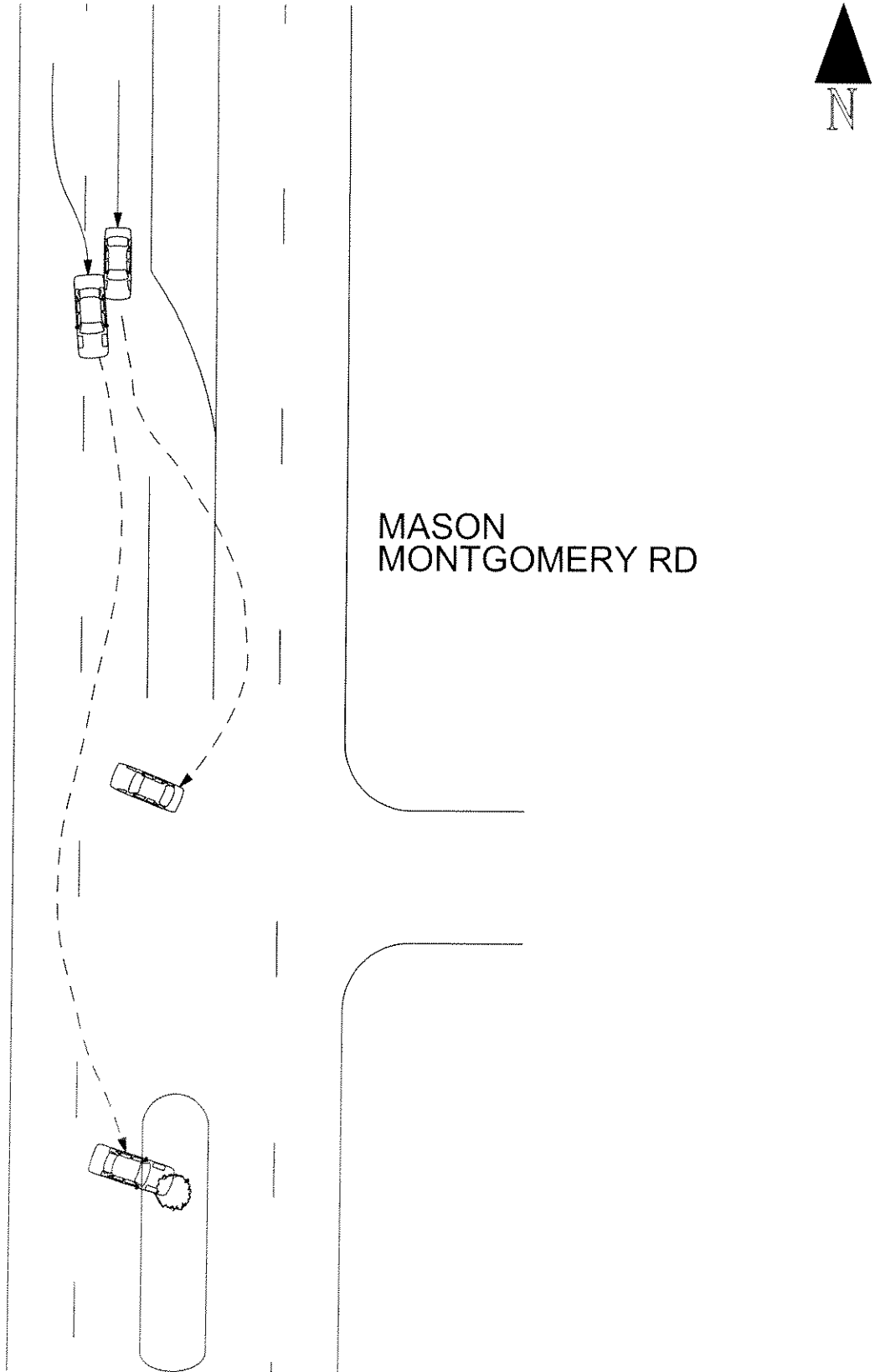

SPEED ANALYSIS

Toyota Camry, 5/22/2014, Mason Montgomery Rd

Officer Burdick requested I take a look at roadway evidence from a traffic crash he had investigated on 5/22/2014 on Mason Montgomery Rd near Western Row Rd. A Toyota Camry changed from the right to the left lane. Its left rear struck the right front on another vehicle, causing the other vehicle to spin out. The Toyota then struck and uprooted a tree in the median near the entrance to Hope Church.

Immediately after impact, the Toyota's driver swerved back to the right, then left again before striking the tree in the median. When the Toyota went to the right, it left a critical speed yaw mark with its left front tire. Officer Fitzgerald and I were able to measure the yaw mark to determine its radius. We used a chord of 40 feet and found a middle ordinate of 6.5 inches. We used another 40 foot chord, starting at the middle ordinate from the first measurement, and found a middle ordinate of 8 inches for the second chord. This indicated the vehicle was slowing down.

We then used a drag sled to determine the friction value of the road surface. The road had been newly paved earlier in the week so the pavement was no more than 3 days old. This gave us a drag factor of .90. The first chord and middle ordinate produced a radius of 367 feet and a speed of 70 mph. The second Chord and middle ordinate produced a radius of 303 feet and a speed of 63 mph
