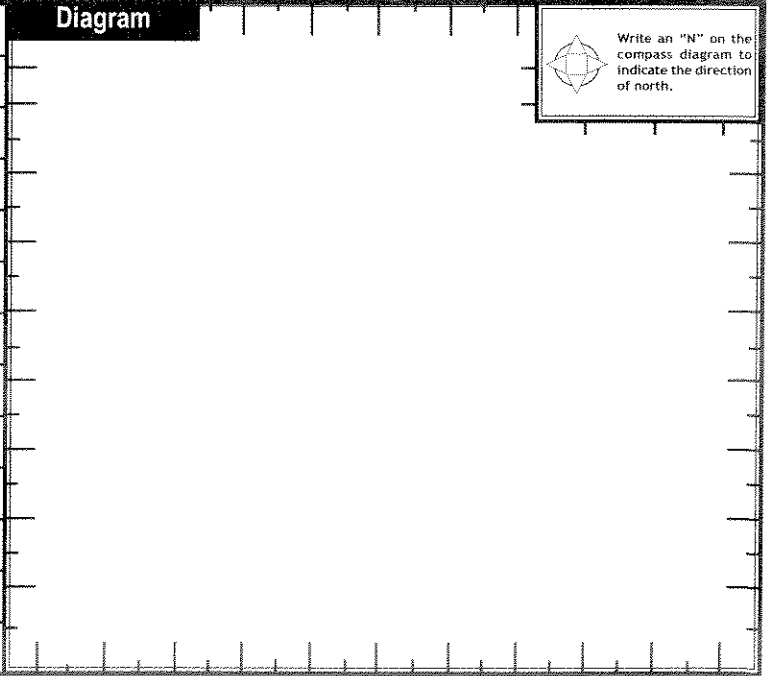

NARRATIVE

UNIT 1 FALLING SOUTH, WAITING TO EXIT PRIVATE DRIVE.

UNIT 2 HEADING WEST ON SOCIALVILLE FOSTERS. UNIT 1 PULLED FROM DRIVE AND STRUCK UNIT 2. UNIT 1 OPERATOR STATED SHE WAS WAIVED OUT BY STOPPED TRAFFIC IN BOTH LANES. UNIT 2 OPERATOR STATED HIS LANE WAS CLEAR AND HE NEVER STOPPED NOR WAIVED UNIT 1 INTO TRAFFIC. NO WITNESSES STAYED ON SCENE.

DEPUTY EMBLETON ARRIVED FIRST AND PUSHED UNIT 2 FROM THE TRAFFIC LANE AND INTO THE TURN LANE. HE STATED THE ORIGINAL REST OF UNIT 2 WAS MUSTLY IN THE LEFT LANE, WITH THE LEFT FRONT WHEEL JUST OVER THE MARKED TURN LANE LINE.

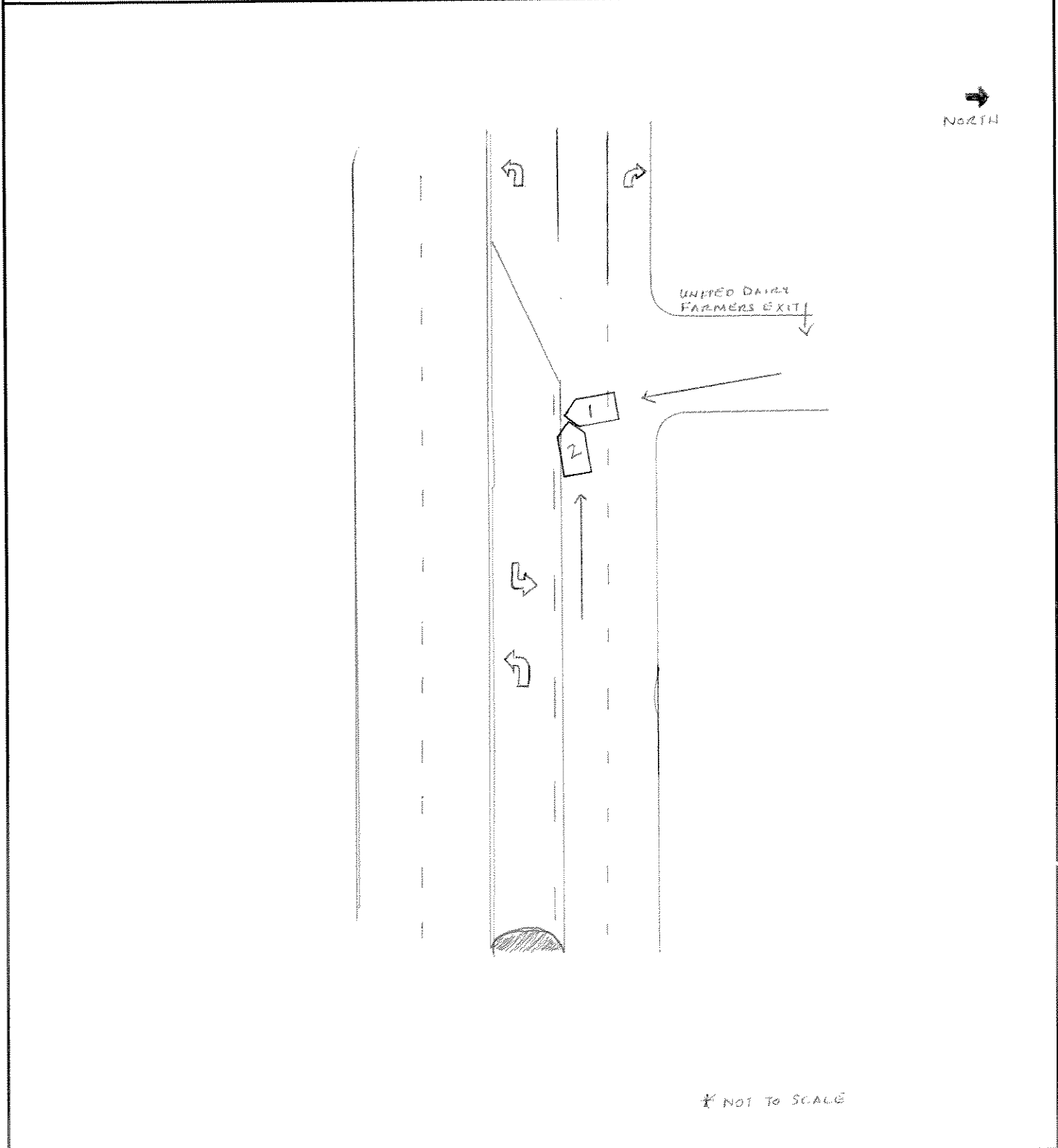
