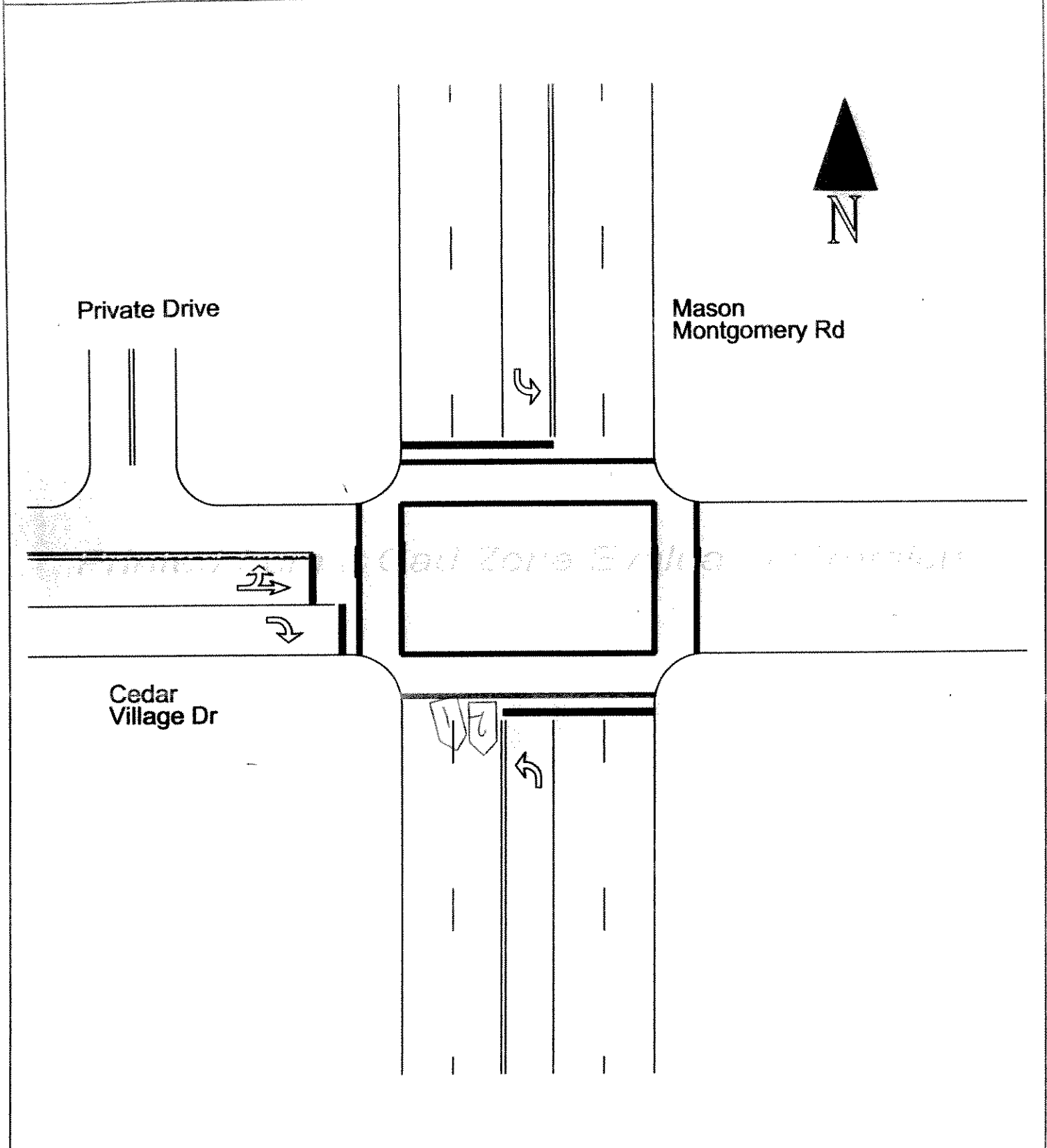

We were driving south on Mason-Montgomery approaching Cedar Village Drive I noticed oncoming traffic turning left in front of us and noticed the other vehicle slowly pulling out of Cedar Village Drive from the right. We had the green light, right of way when the other car, once on ~~Mason~~ Mason-Montgomery turned into our lane. I honked the horn loudly and ~~we~~ applied the breaks as hard as possible, but pulling a camper the vehicles could not slow fast enough to miss the other car. We were also right at the median, so we could not swerve much to miss the other car. Once all cars stopped, I got out of our van, assessed that no damage was on the road and pulled the last piece of the running board off the van (rest of the board was dragging on the ground, from front to back). I instructed the other driver to turn left at the next street (White Blossom Blvd.) to clear Mason-Montgomery. Once on White Blossom I allowed the other driver to use my <sup>cell</sup> phone to call her husband.
