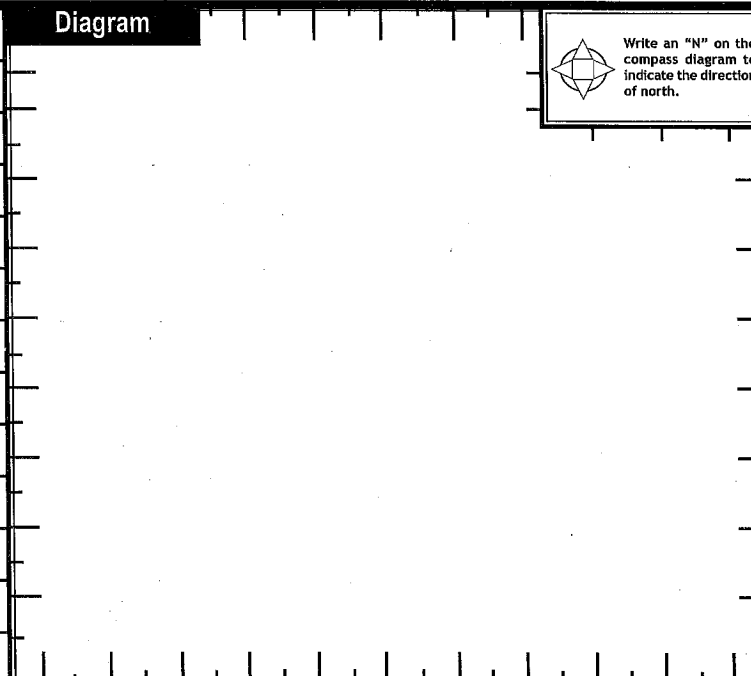

UNIT 1 FAILED TO LEAVE ASSUMED CLEAR DISTANCE BETWEEN THEMSELVES AND UNIT 2 AND REAR ENDED UNIT 2. THE IMPACT CAUSED MINOR DAMAGE TO UNIT 2 AND DISABLING DAMAGE TO UNIT 1.

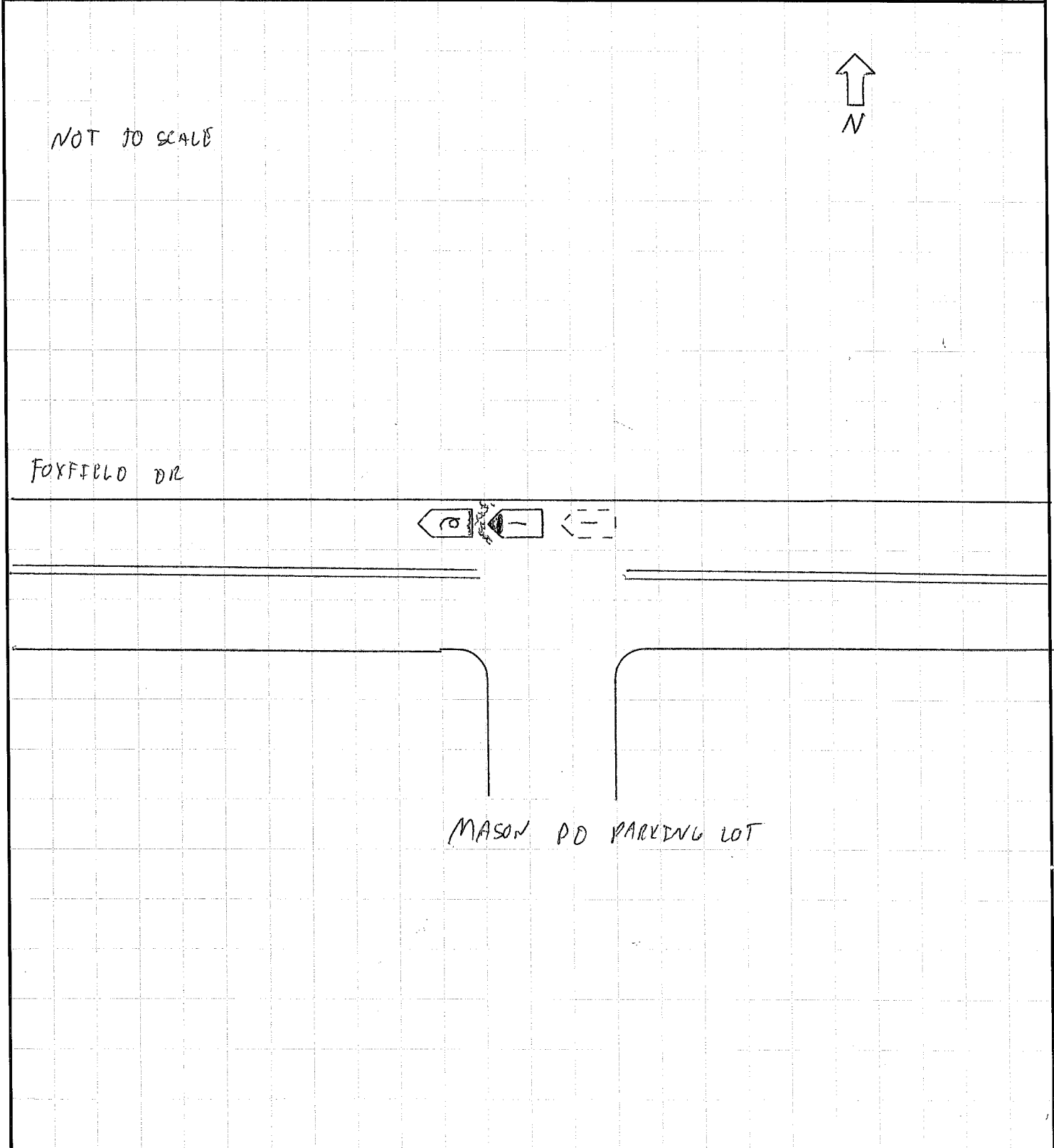
