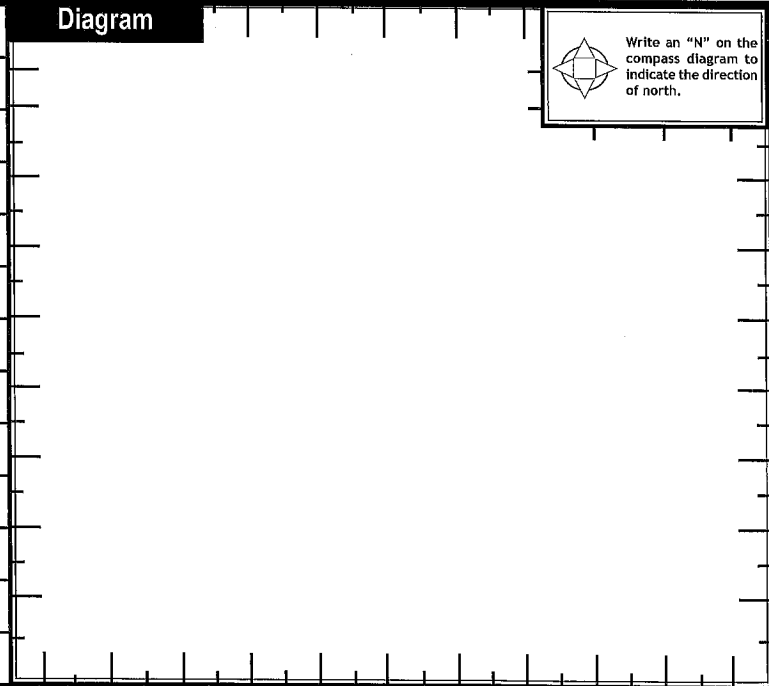



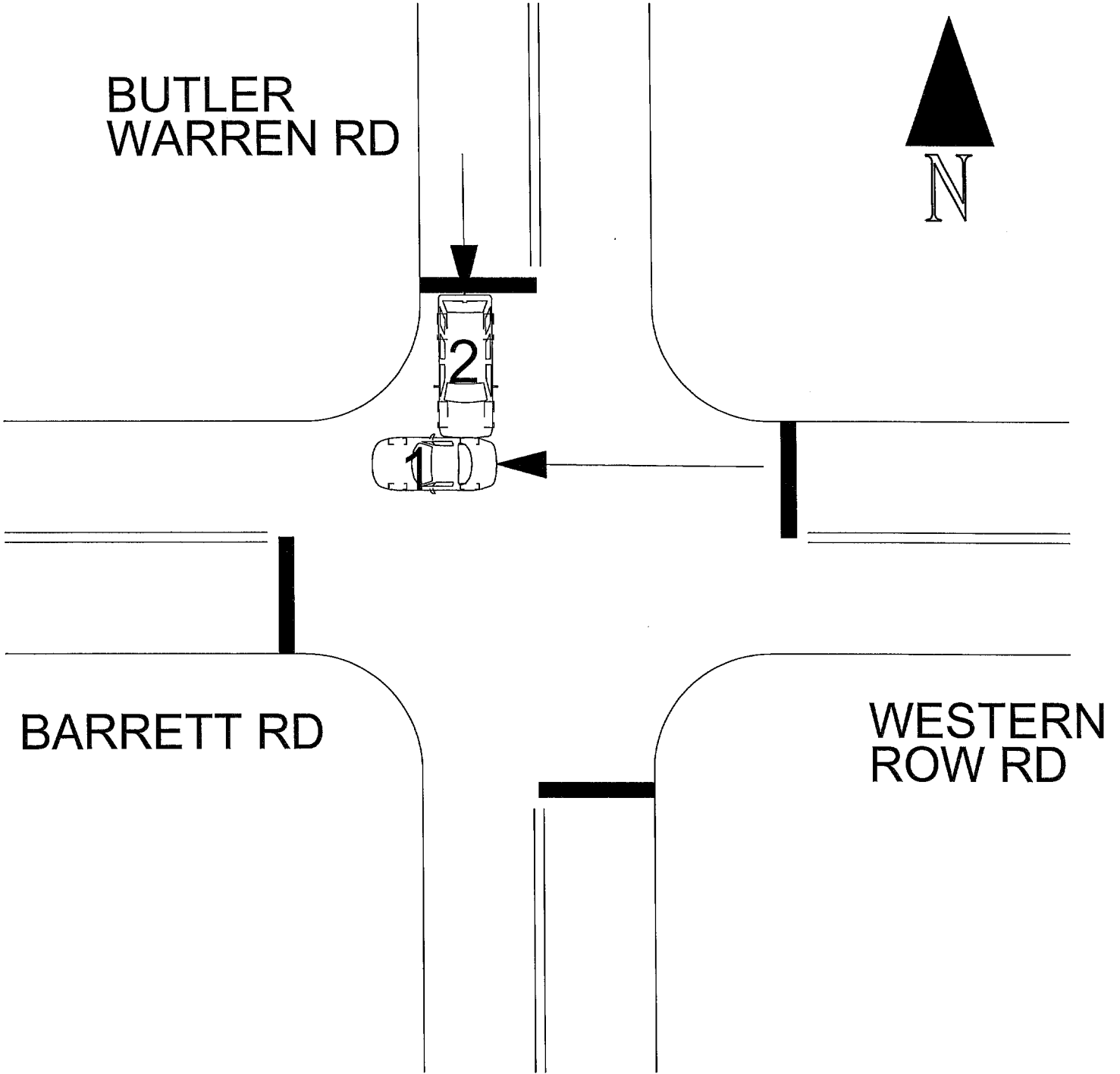

Notes:

I met with Mr. Sloan and was provided a possible license plate, EYZ7841, from a witness to the crash. The plate given did not return to the vehicle description given by Mr. Sloan. I used OHLEG to check on a portion of the license plate. I used the last four digits on the plate, 7841, along with its make, model and color and located a white Buick Rendezvous, with the license plate FYZ7841 registered to Daniel Applegate, 5857 Hassman Dr, Mason. This address is less than a mile from the scene of the crash. On 9/29/2015 at approximately 1700 hours, I was on Hassman Dr, going to the Applegate house when I passed the Buick in question driving away from the house. I stopped the Buick on Tylers Ct and made contact with the driver, Elise Applegate. I explained why I stopped her and what I was investigating. She stated the Buick was not in the area of the crash on 9/26/2015 and didn't know anything about the crash. There was damage to the front of the Buick where I would expect the collision would have taken place, but Ms. Applegate stated the damage was from an old crash in the Blue Ash. Some of the damage I saw on the front of the Buick could not have come from this crash. There was a streak of red paint on the passenger side of the front bumper, as well as damage to the hood and right headlight cover. There was also a black area that appeared to be from a rotating tire on the front bumper. This could have been from the impact with Mr. Sloan's vehicle.

I contacted both witnesses listed in Mr. Sloan's statement. Neither witness could see or identify the driver of the Buick. They both stated, after striking Mr. Sloan's car, the Buick fled south on Butler Warren Rd and ran a red light making a left turn onto US 42. Mr. Sloan, also did not see the driver of the Buick.

I believe this was the vehicle that struck Mr. Sloan's car. The damage on the front is consistent with the damage that I would expect to see. The vehicle was reported to be a white Buick Rendezvous and the plate given was just one character off of a vehicle registered to an address less than a mile from the scene. But, with no one able to identify a driver, I could not go forward with charges against the owner or Ms. Applegate.
