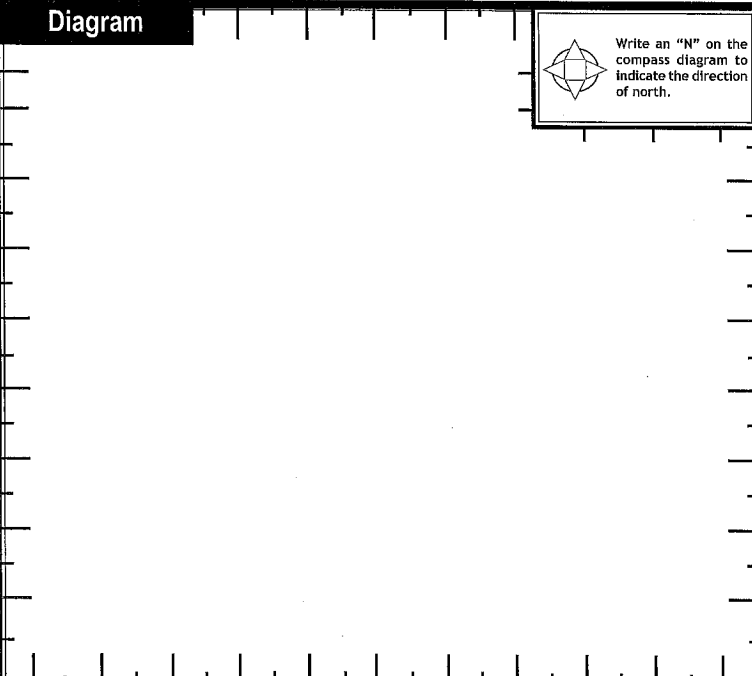

THE WITNESS WAS SPOKEN TO VIA PUBLIC SERVICE AND PROVIDED A VERBAL STATEMENT.





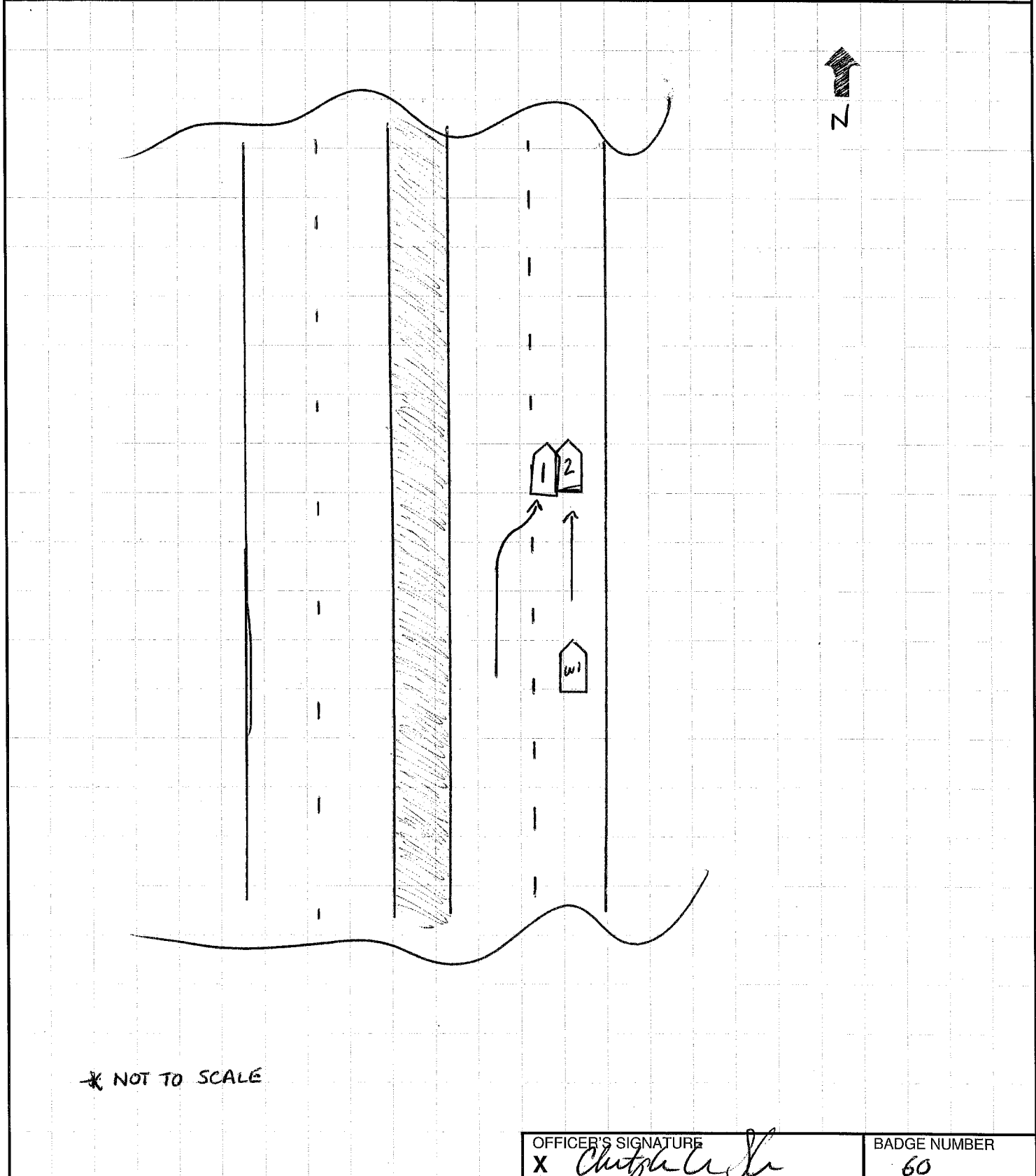
